Tips and Tricks for Trust and Estate Litigation

Richard Bryan is a 1960 graduate of the University of California, Berkeley. He obtained his J.D. degree from UC Berkeley in 1963 and was admitted to the California State Bar in January of 1964. Upon graduation, he became the Law Clerk to Judge Alfonso Zirpoli of the U. S. District Court in San Francisco.

He was then appointed as Assistant Public Defender in Alameda County. Thereafter he became the first associate and the first non-founder partner of the San Francisco law firm of Farella, Braun & Martel. He later formed his own firm, and in 1996, the firm became known as Bryan and Hinshaw, where he continues to practice at this time.

Mr. Bryan has focused on trial advocacy, litigation, negotiations, and acted as a mediator and arbitrator in several areas of the law. He has tried many cases to verdict in criminal law, construction law, and professional malpractice in earlier years. Over several decades, he focused on probate and trust litigation, family law, and general civil litigation. He was honored by election to the American Board of Trial Advocates, and the Presidency of the Barristers Club of San Francisco. He served as a member of the Board of Directors of the Bar Association of San Francisco and a Delegate to the Conference of Delegates of the State Bar of California.

He has lectured and taught frequently in continuing education classes, on trial advocacy, negotiation, mediation, and arbitration. Most notably for several decades he served on the faculty of the Rutter Group basic class on Civil Procedure with Judge Ira Brown and Judge Richard Kramer of the San Francisco Superior Court.
